## **PASTOR'S REPORT**

### **Lead Pastor's Annual Report**

Grace and Peace to you all from God our Father in heaven and our Lord Jesus Christ. May the Spirit of God be with you in this very new year given to us as a gift from God.

**Leading Worship and Preaching:** These two weekly tasks have been shared equally between Pastor Bailie and me, one presides over the sacrament and the other preaches, until his resignation in September. After that, I have presided over all of the Sunday and Wednesday Advent services. I preached at the Lenten services with the other Lutheran churches in Ashtabula (and Madison). Our Advent services were held in the gathering space this year and were quiet and contemplative. I also preached at the Church of Christ for the CAMA Lenten services on a Sunday evening.

**Visitations and Villa Services:** There were visits performed at least one a week sometimes with more than one individual at a time. The Villa Services have been kept up by Andy Chiodo, Shirley Harco, and me. We perform a shorten service of worship at the Villa on the first Sunday and the Third Tuesday of the month. We continue with a service at Lake Point Rehabilitation on the third Tuesday, also. We will be performing that service every month: 12:30 at Lake Point and 1:30 at the Villa.

**Baptisms:** Pastor Bailie and I have divided the duties of baptisms during 2019. There have been three baptisms in the past year, 1 infant and 2 children.

**Confirmation:** Pastor Bailie, our Youth and Family minister, was responsible for teaching and performing the rite of Affirmation of Baptism in 2019. I am taking those responsibilities over now that Pastor Bailie is no longer with us. Confirmation is proceeding with 11 confirmands.

**Funerals:** I performed six funeral services for members of Good Shepherd.

### Purpose

The Endowment Committee oversees three endowment funds. Our principle responsibilities are to prudently invest the funds and to manage the accounts in complete compliance with the bylaws. The bylaws allow for distributions of income or growth but never the principal. The following is a brief description of each fund, the 2019 activities, and investment performances.

### Capital Improvement Fund

As the name implies, this fund was established to provide funding for the purchase and maintenance of capital assets (land, buildings, and equipment) owned by Good Shepherd as well as making loan payments associated with those assets. In 2019 we made two disbursements; 1) \$5,625 on July 19<sup>th</sup> to pay for a Kubota lawn mower and 2) \$1,200 on October 16<sup>th</sup> to help pay for new tables and chairs.

### Mission and Education Fund

The purpose of this fund is to provide funding for internal and external missions of Good Shepherd and to provide higher education scholarships for qualified members. In 2019 there were no disbursements as only one applied for a scholarship but did not qualify because of attendance.

### Family Center Fund

This was the fifth year for the Family Center Fund, having started with \$20,000 in February 2015. The cash came from donations and funds raised over several years from GSLC members and other citizens of Conneaut with the long-term goal of building a family center on the west side of Grove Street.

The U.S. stock markets were very strong throughout 2019 and all three of our investment accounts with Vanguard did extremely well. Collectively we gained \$149,269 when adjusting for the \$6,825 withdrawals. These results were well above normal and we expect the investment returns to be good but more moderate in 2020. Most market analysts are predicting continued growth in the economy, low inflation, favorable lending interest rates, and no recession for at least the next 12-18 months. We will base our investment strategy accordingly.

*“Leadership Lessons from Geese” by Joel Barfinkle*

Have you ever wondered why geese fly in a V formation?

As with most animal behavior, God had a good reason for including that in their instincts.

As each bird flaps its wings, it creates uplift for the bird following.

In a V formation, the whole flock adds at least 71% more flying range than if each bird flew alone.

Whenever a goose falls out of formation, it suddenly feels the drag and resistance of trying to fly alone.

Can get where they are going quicker and easier than those who try to go it alone

When a goose gets tired, it rotates back into formation and another goose flies at the point position

Geese in the rear of the formation honk to encourage those up in front to up their speed. It's important that our "honking from behind" be encouraging.

Otherwise... well...it's just honking.

When a goose gets sick or wounded, two other geese drop out of formation and follow it down to provide protection.

They stay with the unhealthy member of the flock until they are able to fly again.

Then they launch out with another passing flock or try to catch up with their own.

May we be so sacrificial, that we may be worthy of such friends in our times of need.

You don't have to be a scientist to learn from God's marvelous creation.

You only need to stop long enough to observe and let God reveal His wonders to you.
